



### Minnesota Department of Education Safety, Health and Nutrition Division - Food Distribution Program Minnesota Approved Distributors for Regular USDA Foods

The Food Distribution Program requires participating sponsors to select a Minnesota approved distributor for delivery of their Regular USDA Foods (please see list below) and enter into CLiCS 1 by May 15 for school year 2012-2013 (SY2013). Please remember it is important to have a signed contract between the sponsor and their chosen approved distributor of Regular USDA Foods before entering the distributor selection into CliCS 1. Please be advised:

- The distributor selection cannot be changed after the date of May 15, 2012 for SY2013.
- The action alone of selecting a distributor in CliCS 1 does not constitute a contract with a distributor.
- The distributor contract is between the sponsor and their sponsor selected distributor.

#### <u>Instructions for Selecting a Distributor in CLiCS 1:</u>

#### Log into CLiCS 1

Select "Food Distribution+"

Select "Profile"

Select the "Customers" (green) tab

Select applicable year – "2013"

Select "Search"

Select the program year hyperlink under

The Commodity Customer Maintenance Profile screen for the applicable year will appear.

Within this screen, change the distributor entry "0-None Selected" by selecting a distributor name from the "Distributor" pull down menu.

Select "Save" located at the bottom right of the screen.

When the message "Changes have been accepted" appears, selection of a distributor is complete.
